No cancellations due to weather.

RENTAL AGREEMENT

Upon receiving your initial deposit and a signed and dated copy of the Rental Agreement, a rental confirmation will be mailed/e-mailed to you.

Once we receive full payment for your reservation, you will be given the keyless entry code the week of your check-in.

HOUSEKEEPING

When you arrive, the home will be clean and set up with linens and as a courtesy we have included the following list of starter supplies to accommodate the appropriate amount of guests:

- Bath towels, hand towels, wash clothes, paper towels, and napkins
- Dishwasher soap, hand soap, toilet paper, laundry soap and softener
- **Beach Towels:** Please bring your own, these are not provided. **Equipment:** some beach equipment may be available in the exterior closet.

This is a non-smoking villa. You are permitted to smoke outdoors on the deck. Butts are to be disposed of properly and not left anywhere on the property. Any violation of the smoking policy will incur a \$150.00 fine and if additional cleaning is necessary to remove smoke odours from the house and/or linens, costs will be charged to your credit card.

Telephone service is local and emergency only. Long distance calls can be made with a calling card or credit card.

Check-in time is no earlier than 4 pm ET. There is only a 6 hour window to completely clean, disinfect and set up for the next guests. Please respect this work schedule. If you arrive early you are free to use the amenities provided by the Palmentto Dunes complex but do **NOT** enter the Villa early. Allow our cleaning service time and space to prepare the Villa for you. If our cleaning service reports to us that they are impeded in their ability to clean you will be billed an additional \$150 on your enclosed account number.

Checkout time is no later than 10 am ET the day you are scheduled to leave. We must be able to enter the home at 10 a.m. If you do not vacate the premises on time, you will be charged \$50.00 an hour up to the second hour and then one (1) additional night's stay for time exceeding second hour.

Checkout procedures: Prior to checkout, all dishes should be washed and put away. Beds may be left unmade and sheets and pillowcases left on. Towels should be placed in bathrooms. Make sure all doors and windows are locked and shut.

We will not be liable or responsible for personal items left behind, lost or stolen. If you leave an item after checking out and wish to have it returned, call us as soon as possible and we will arrange for shipment. We will inform you of the shipping cost and with your approval, charge your credit card to cover the expense.

Please remember that anything that goes down the drain goes right into the watershed and is absorbed by the environment. DO NOT USE LIQUID PLUMBER OR THESE TYPES OF PRODUCTS. These products stay in the sewer system and pollute the watershed.

ADDITIONAL TERMS

You must be 25 years of age to rent this home and provide proof of age, if requested.

The Villa has a maximum occupancy of eight (8) guests. Renters who exceed the occupancy limit and falsify occupancy information at the time of reservation are subject to eviction.

RV's, Trailers, Boats and Motorcycles are not allowed in any plantation or villas complex.

Furnishings in the villa are NOT to be removed, moved or rearranged.

House parties are strictly prohibited and grounds for immediate eviction.

Illegal substances are strictly prohibited and grounds for immediate eviction.

There is an abundance of wildlife in the area. Guests are to respect nature and take care to guard themselves and their guests as appropriate.

Any exceptions to the rules and regulations as written here, must be approved in writing by owner in advance.

Rates, terms and conditions are subject to change without notice.
